MONOGRAPHS IN PREPARATION:

Terra Matris: The Military Orders and Landscape Sacralization during the Baltic Crusades (13th – 14th Century). In preparation for submission as first monograph.

• Summary: This monograph will be the first of its kind in English to address, exclusively, the development of crusading ideology and the military orders in the Baltic region. It also addresses the importance of language, image, experience, and ritual (including sound) amongst members of the Teutonic Order and secular crusaders in the Baltic during the peak of the crusader period. The book provides an in-depth analysis of key themes and language present in the large variety of sources available for the period, and uses them in combination with qualitative Geographical Information Systems (GIS) analysis to map and visualize the development of a new sacred landscape in this final religious frontier of medieval Europe.

• <u>Summary:</u> This invited contribution suggests comparisons between the castles of the Teutonic Order in the Holy Land and in the Baltic region not through architectural grounds, but through considerations of the ways in which castles were perceived in both regions as spaces associated with the Order's monastic obligations and as places for displaying its crusading ideology.

• <u>Summary:</u> This collaborative article analyses an image of St Christopher, painted sometime around the end of the 14th century, within the context of hierotopy (the creation of sacred spaces through ritual) proposed by Alexei Lidov. It suggests a new dating for the painting and a new patron (Heinrich von Plauen, deposed Hochmeister of the Teutonic

Order). After analyzing the Middle High German version of the vita of St Christopher in Das Passional, the article connects the iconography to the story, and then suggests Heinrich von Plauen chose this image as a means to reflect on his deposition and status within the Order, and therefore the image is an example of the creation of sacred space in the private sphere in the Later Middle Ages.
